Purposes and provisions

The objects for which the corporation is incorporated are:

Board of Directors

The affairs of the Corporation shall be under the direction and control of the Board of Directors. The directors may exercise any powers and make, or cause to be made, any actions, contracts or perform any matters for and on behalf of the Corporation as the Corporation may otherwise lawfully do. The Board shall be not less than three (3) and up to eight (8) elected directors.

- (c) A director must not be affiliated with, or have a Family member affiliated with, any other gymnastics club in Chatham-Kent.
